**AGREEMENT ON ASSESSMENT
OF THE NON-PECUNIARY

Pursuant to the Decision of the Company's General Meeting on the increase of the initial capital of company .A.S.A. Kikinda d.o.o. Kikinda, No. bb, Idjoski put Street, the total subscribed and paid initial capital in the amount of 1000,00 EUR is increased by the new pecuniary investment of A.S.A. International Environmental Services Gmbh Austria in the amount of **€ 7.490,00** by the new pecuniary investment of A.S.A. Eko d.o.o. Beograd in the amount of **€ 591.710,00** and new non-pecuniary contribution of Municipality Kikinda in the total amount of **€149.800,00**, as it is determined by the Member in this Agreement.

Investment in kind which Municipality of Kikinda will subscribe and contribute to the Company, subject to Decision on the Company's initial capital increase consists of **the non-pecuniary contribution** in kind, in the form of ownership rights on


